## BELMONT HILLS LIBRARY – 6 DAYS A WEEK...?



The Belmont Hills Library is open 5 days a week. All other Township libraries are open 6 or 7 days per week. The Belmont Hills Library Board has asked for a program which would allow it to be open on a 6<sup>th</sup> day (likely Fridays) in 2020. Library attendance is much higher now than it was before the library closed for renovations in 2017, and I absolutely support a 6<sup>th</sup> day. The Township allocates library hours based upon **usage**, so please show that Belmont Hills Library deserves a 6<sup>th</sup> day by visiting and using our great library.

#### MEDICAL MARIJUANA UPDATE

McKee Group (PharmaPenn, LLC d/b/a MedGarden) recently submitted an application to open a medical marijuana facility at 232 Rock Hill Rd (next to CVS). Separate from the Township application, McKee Group will need the State of Pennsylvania to issue it a permit in Phase III of the State's medical marijuana program before it can go forward at 232 Rock Hill Rd. ### **ROCK HILL ROAD APARTMENT PROJECT(S)**

Two apartment projects were recently planned for Rock Hill Rd. Developer Hanover sought to construct a **332-unit**, **5 story** project at **131/151 Rock Hill Rd**, but it <u>has abandoned the project</u>. It is possible that a new project may spring up at that location, and if you are concerned about the site, please keep an eye out for activity. A **34-unit**, **5 story** project is planned for **21 Rock Hill Rd**. I believe the developer plans to make presentations about the project at upcoming meetings of the Neighborhood Club of Bala Cynwyd and Belmont Hills Civic Association. The application is tentatively scheduled to go before the Planning Commission on **Dec. 2**, **2019**.

#### UPDATE RE: SENIOR LIVING CENTER – 211 BELMONT AVE



LCB is constructing a 6-story, high end senior living center at the intersection of Rock Hill Rd and Belmont Ave (opposite to the CVS) in place of the old mill and flower outlet. On Nov. 1, the Township issued a Minor Grading Permit with a "Construction Sequence" requiring control measures which must be installed and inspected by the Township before a demolition permit can be released. There is no demolition date as of now for the old mill/outlet.

The structure is in poor condition which has been described as "demolition by neglect."

The <u>General Election</u> is <u>November 5</u>. Any registered voter can vote (in the primary, a person must be registered to a political party to vote in that party's primary election). Polling places are 3-1 (Belmont Hills Library), 3-2 (Welsh Valley Middle School), and 3-3 (Belmont Hills Fire Company). Polls are open from 7 a.m. to 8 p.m.

5 School Board positions are open, and 7 commissioners spots for the odd-numbered Wards are also open. Commissioner terms are 4 years. From Nov. 6-12, you can drop-off old campaign signs at the Koegel Complex (1300 N Woodbine Ave) as part of a sign recycling program.

**PX Pill Take Back:** On October 26, the LMPD collected 151 pounds of unused or expired medications for safe disposal. I'm glad these items are out of homes, where they could be taken by friends or strangers and used in dangerous ways.

# **JEFFERSON STREET UPDATE**

The water main work is complete. Contractors are currently performing trench restoration, which is a permanent patch and seal to improve road appearance and function. The estimated completion date for this work is <u>Nov. 11, 2019</u>.

Due to funding, timing, and weather, Jefferson Street cannot be repaved this year.

Jefferson Street is scheduled to receive a full pave in 2020 (likely the <u>summer</u>).

The Township will monitor the road throughout the winter and make repairs if needed. If you see a pot hole, large depression, cracking etc., <u>please</u> report the issue to public works.

A Belmont Hills resident has started a traffic calming petition for **Ashland Avenue** to reduce speeding and increase safety. Per Township policy, the petition requires signatures from 80% of the homes on Ashland to qualify for traffic calming. The **Neighborhood Club of Bala Cynwyd** issued a resolution expressing concern that the new zoning will cause excessive density in the eastern portion of the Township. I agree with these concerns and will work to address excessive density. The Resolution is as follows:

Resolution of the Board of the Neighborhood Club of Bala Cynwyd on Tuesday, October 15, 2019 (passed 9-0) Regarding Increased Density Under the Proposed New Zoning Code

The Board of Directors of the Neighborhood Club of Bala Cynwyd expresses concern about the New Zoning Code's unfairly and inequitably allowing increased density in zoning districts in Bala Cynwyd and the eastern part of the Township and urges the Township to readjust the Code so that any increased density is equitably distributed throughout the Township.

Restoring the native plant and tree habitat is vital to preserving biodiversity, which helps our stormwater runoff, birds, air, local environment etc. If you are planting trees, please try to plant **native species** which will fit in with our ecosystem.
